NC VOTER REGISTRATION APPLICATION INSTRUCTIONS

Your may use this form to:

- Register to vote in your county of residence in North Carolina.
- Update your name, address, party affiliation, or other information in your voter registration record.
- Cancel your previous registration in a previous county or state.

Eligibility to vote:

- You must be a citizen of the United States.
- You must be at least 18 years of age, or you will be 18 years of age by the next general election and you are voting in the primary.
- You must have resided in the precinct for at least 30 days prior to the election.
- You must not be currently serving a felony sentence. If previously convicted of a felony, you must have fully completed your sentence, including probation and/or parole. No special document is required.

Voter Registration and Declination Statement:

If you are submitting this application to a public assistance agency or the North Carolina Division of Motor Vehicles, the location or office where you submitted this application will remain confidential and will be used only for voter registration purposes. If you decline to register to vote at a public assistance agency or the North Carolina Division of Motor Vehicles, the fact that you so declined will remain confidential and will be used only for voter registration will remain confidential and will be used only for voter registration purposes.

Registration Deadline:

To meet the regular application deadline, this form must be postmarked or delivered to your county board of elections office no later than $\frac{25 \text{ days}}{25 \text{ days}}$ before the date of the first election in which you desire to vote. Contact your county board of elections office to learn about additional registration options that may be available.

Submitting Your Form:

If you are registering for the first time in your county of residence, or if you are changing your party affiliation, your county board of elections must receive your application with an original signature. If you are currently registered to vote in your county of residence and you are using this form to update your name, address, or other information, you may also fax or email a scanned image of your signed application. You should submit your signed application to your county board of elections. Visit **www.NCSBE.gov** for the address, fax number, or email for your county board of elections.

Identification Requirements:

Registration ID — Under federal and state law, if you register to vote by mail and do not provide a valid identification number in Section 3, you must include a copy of one of the following documents with this application:

- A current and valid photo ID.
- A current utility bill, bank statement, government check, paycheck, or other government document that shows your name and address.

If you do not provide a valid identification number in Section 3 or submit a copy of one of the above identification documents, you must present one of the above identification documents the first time you appear to vote.
